Action on Minutes of Previous Meetings as Follows

Minutes of the Town Board Meeting of September 7, 2023 and Agenda Meeting of September 26, 2023 were presented to the Board. A motion was made by Councilman Boudreau, seconded by Councilwoman Marble to accept the minutes as presented. All voted in favor of the motion.

Committee Reports

Financial Report and Submission of Bills and Petty Cash

Supervisor Lawler read the financial reports for the month of September 2023. The audited vouchers totaled \$563,852.54 and the payments in advance of audit totaled \$35,731.74. The petty cash report totaled \$71.23. A motion to accept the financial report, pay the abstracts and reimburse petty cash was made by Councilman Ball and seconded by Councilman Boudreau. All voted in favor of the motion.

Committee on Highway, Wastewater Treatment, Water Authority, Cemetery, Museum and Town Historian

Councilman Boudreau read the monthly report from the Highway Department.

All town hall fields and parks were moved and maintained. All vehicles and ed

All town ball fields and parks were mowed and maintained. All vehicles and equipment continue to be serviced and repaired. The Jet/Vac truck was used to assist in water mitigation during a culvert pipe replacement. A sinkhole was found in the road on Canvasback Ridge requiring the storm water culvert pipe to be replaced. Storm water drainage improvements were made on Timber Drive in front of Catallo Park. Street signs were replaced on Mallards Landing North, Clemente Lane, Morgan Lane, Lea Ave, Hill Street and 3 speed limit signs were replaced on Devitt Road. An exploratory dig was done on Mohawk Ave after a sinkhole was discovered in the road. Voids were found from a previous fire hydrant install. The area was properly compacted and road surface was repaired. 22 Tons of #2 Stone was used for culvert pipe installation. 24 Tons of crusher stone was used for road repair and parking lot improvements at the Middletown Rd ball fields. 5.5 tons of Type 3 Binder and 7 tons of Type 7 Blacktop was used for road repair. 120 Yards of trash was collected. 300 Yards of green waste was collected.

The Highway department responded to 21 service requests and processed 33 Dig Safe requests with 3 emergencies. We would like to remind everyone the next trash drop off day is October 14th 8AM to 1PM. Household Hazardous Waste Day will be held October 21, 2023 from 8am to 1pm registration is required. If you have any questions please call the Highway Department at 518-235-3413.

Councilman Boudreau then read the September 2023 report from the Wastewater Department as submitted by Craig F. Falcone, Chief Operator.

Average Influent Flow: 876,000 gallons/day, Monthly rainfall: 3.56" at the treatment plant We removed: 6,000 gallons of sludge to Albany County, 50,000 gallons of sludge to Saratoga County

Alarms answered:3, High Flow-1, Power-2, Mechanical-0, Testing-0 Normal Maintenance:

Checked all pump stations and cleaned floats as needed. Continued maintenance of outside grounds, equipment, and vehicles. Removed influent primary grease from primary tanks and weirs on weekly basis.

Tom Koval from Koval Electric inspected the power control panel and replaced damaged wire at the Towpath Lane pump station.

We used the Vac truck to clean out the Front St, Suncrest Drive, Timber Drive, Murray Ave, Mallards North and South, Towpath Lane, and Fonda Road pump stations.

We drained, cleaned, and inspected the river side final clarifier, adjusted the cross collector chain, and put the tank back into service.

The A-Team installed a repair coupling on the discharge piping in the Canvasback Ridge pump station.

We took part in and passed our annual EPA DMR-QA lab testing.

BPI Piping performed the annual water backflow testing, backflows at the sewer plant and Third St. pump station were tested and passed.

We coated a portion of the plant pump station power and control building roof which had sprung a leak adjacent to the drain.

Constructed a crusher run walkway over the generator control cables after the conduit had been replaced at the James Drive pump station.

Troy belting inspected the generator controls, adjusted the backup power supply feed and replaced the generator battery at the Mechanicville Road pump station.

The Councilman then went on to read the monthly report from the Waterford Water Commissioners.

<u>Water Consumption</u> - The Water Works delivered approximately 29,524,672 gallons or 952,409 gpd of water during the month.

<u>Water Distribution System Work</u> - The staff completed approximately 30 dig-safe utility locations as well as 73 service calls during the month. In addition to calls, staff calibrated & maintained equipment, completed monthly water testing and completed meter reading.

<u>Meter Installation</u> -Staff continues to reach out to residents and schedule replacement of old meters with drive by read meters. Staff have logged 2733 meters installed to date.

<u>Hydrant Maintenance</u> - Maintenance and painting is completed; we have completed maintenance and painted all hydrants this season. If there are any questions or concerns, we can be reached through our website www.waterfordwater.org or by phone 518-237-0422.

Get the lead out - We have completed our Service Inventory Report for the NYS DOH. We are combining that with our action plan and will be filing it with the DOH in October, a year ahead of our deadline. We currently have 3308 services. There are 57 customers' services that contain lead, and 161 services that have been identified as unknown. We will be launching a project to identify those services in the new year and will formulate our plan for replacement.

Councilman Boudreau went on to read an update from Town Historian Russ Vandervoort. On September 9th, in conjunction with the Waterford Tugboat Roundup, presented a program on the first opening of the Champlain Canal's 200th Anniversary in Waterford, on the very day it happened 200 years ago.

September 17 - 20, was in attendance at the annual conference of Public Historians of New York in Ithaca. I was one of the presenters on the Tuesday schedule. The theme this year was various methods of "At home in New York." My 45-minute segment was "Life on the Water," detailing the living conditions of those who lived aboard the boats they worked on. Waterford, of course, was used as a study and reference point.

September 26th conducted a walking tour for the Saratoga County History Center. Starting at the Waterford Harbor Visitor Center, we met at the site of the Button Engine Co., then proceeded up Third to Broad, and then down to Soldiers & Sailors Park. Mention was made through out of the many historical buildings and sites along the way. There were 40 in attendance. The President of the SCHC thanked us for a perfect tour.

I received a memorial booklet from the family of Art Chouinire. He was a WWII airman from Waterford whose plane was lost in the war with all aboard. The families of all the airmen met this year in Europe on the 80th anniversary of the event. The booklet is a nice piece of history. Continued collaboration with former Waterford Museum Director, now a Senior Historian with the NYS Museum, Brad Utter, is turning up interesting facts about Waterford's past.

Committee on Public Safety, Emergency Services, and Liaison to Village

Councilman Ball read the summary of police activity for the month of September 2023: 38 Arrests, 132 traffic tickets, 15 motor vehicle accidents, 553 calls for service Other activity: Officer Muzzi successfully completed the Department's Field Training program and was released to solo patrol.

The Department was awarded \$6,864 in grant money from the Governor's Traffic Safety Committee for 2024.

Councilman Ball referred to the status of investigations report. It will be slimed down next month.

Councilman Ball stated that the Halfmoon Waterford Fire District and Northside Fire have posted their public hearings on their proposed budgets. The Waterford Fire Department is part of the Village budget and also a part of the Town Budget as well.

The Councilman then stated that the Town lost a vehicle this month. We did receive a quote for a new vehicle, \$39,571.00, a Dodge Durango that is ready now. We are not sure what will be available next year due to availability and the strike. We received close to \$17,000 from insurance proceeds for the Ford Explorer. He would like to consider moving on this tonight.

Councilwoman Marble read the Waterford Visitor Center report for the month of September as submitted by Harbormaster Jeff Cleary.

The legendary Tugboat Round-up took place on September 8th, 9th and 10th. The Tugboat Parade, Fireworks and Tug Chug, 5K road race as well as the line toss competition and the ever-popular nose to nose competition were all well received by the very large crowds that enjoyed the festivities. The John J. Harvey Fire Boat was, as always, a crowd pleaser. Many thanks to all the volunteers that helped make the weekend a huge success.

For the month of September, we welcomed 147 boats from 27 states, 4 Canadian provinces as well as Germany and New Zealand. To date we have welcomed 783 boats from 41 States and 9 countries, including 4 Canadian Provence's. Also, in September, our volunteers recorded 592 hours of service, and 2132 hours of service year to date. Thank you.

The Councilwoman then read the September report for the Building Department from Ben Akin. There were 19 building permits issued and 2 demolition permits: 1 being an unsafe accessory structure on Clifton St. and 1 being the planned removal of 46 Bells Lane in line with the development of the storage unit project. There were 3 stop work orders issued, 1 fire call, 26 on sight construction inspections, 46 stops for roadside trash and 5 stops for overgrowth. Over the last 2 months I have been working with 3 different property owners in the town to get the living conditions back to a safe environment. Everyone in contact for the properties have been moving in a positive direction. A total of 220 yards of items and debris has been removed from the interior and exterior of the combined properties. There are 2 landlord tenant disputes, both ongoing.

WHEREAS, on September 12, 2023, a fire safety inspection was conducted on the Town of Waterford's Highway Garage by the Town of Waterford's Building and Zoning Officer and it was determined that all of the Town of Waterford's Highway Garage's overhead doors posed an imminent safety risk to the public as well as to the Town of Waterford employees as all of said overhead doors had a heavy amount of rot and all of the safety functions on said overhead doors were currently inoperable;

WHEREAS, the Town of Waterford's Building and Zoning Officer, as a result of his aforementioned September 12, 2023 fire safety inspection of the Town of Waterford's Highway Garage, issued a report, dated September 29, 2023, detailing the findings of said fire safety inspection and recommending the immediate removal and replacement of the Town of Waterford's Highway Garage's overhead doors due to the imminent danger that said overhead doors posed to the public and the Town of Waterford employees;

WHEREAS, Section 103(4) of the New York State General Municipal Law provides that, in cases of an emergency situation arising from unforeseen circumstances affecting public property or the health and safety of the public, the Town Board may authorize the purchase of services, material and equipment without competitive bidding;

WHEREAS, the Town of Waterford's Building and Zoning Officer, as a result of his aforementioned September 12, 2023 fire safety inspection of the Town of Waterford's Highway Garage, issued a report, dated September 29, 2023, detailing the findings of said fire safety inspection and recommending the immediate removal and replacement of the framework of the Town of Waterford's Highway Garage's overhead doors due to the imminent danger that said framework posed to public and the Town of Waterford employees;

WHEREAS, the Town of Waterford's Tony Lubas engaged Rozell Industries to furnish the Town of Waterford with a proposal to immediately remove and replace the framework of the Town of Waterford's Highway Garage's overhead doors;

WHEREAS, Rozell Industries has furnished the Town of Waterford with a proposal to immediately remove and replace the framework of the Town of Waterford's Highway Garage's overhead doors for the sum of \$14,096.00;

WHEREAS, Section 103(4) of the New York State General Municipal Law provides that, in cases of an emergency situation arising from unforeseen circumstances affecting public property or the health and safety of the public, the Town Board may authorize the purchase of services, material and equipment without competitive bidding;

NOW THEREFORE BE IT RESOLVED THAT the Town Board determines that the current condition of the framework of the Town of Waterford's Highway Garage's overhead doors, as

observed during a September 12, 2023 inspection by the Town of Waterford's Building and Zoning Officer and detailed in his September 29, 2023 report, constitutes an emergency for procurement purposes under Section 103(4) of New York State General Municipal Law;

NOW THEREFORE BE IT FURTHER RESOLVED THAT the Town Board's Supervisor is hereby directed to authorize Rozell Industries to proceed with the immediate removal and replacement of the framework of the Town of Waterford's Highway Garage's overhead doors pursuant to its proposal dated September 27, 2023;

NOW THEREFORE BE IT FURTHER RESOLVED THAT the Town Board's Supervisor is hereby authorized to compensate Rozell Industries the amount of \$14,096 for the immediate removal and replacement of the framework of the Town of Waterford's Highway Garage's overhead doors.
